

## KEY INFORMATION DOCUMENT – COMMODITIES CFD

### Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

#### Type

An Over the Counter (“OTC”) Derivative Contract for Differences (“CFD”) on Commodities.

#### Objectives

The objective of the CFD is to allow an investor to gain leveraged exposure to the movement in the value of the underlying market (whether up or down), without actually owning the underlying asset. A Commodities CFD is an agreement between you and the Company to exchange the difference in price of the underlying asset over a period of time. The investor makes a profit or a loss on the CFD based on the direction chosen (Buy/Long or Sell/Short) and the direction of the value of the underlying asset. The CFD is settled in cash only and the investor has no rights whatsoever to the actual underlying asset. The market for most commodities is open 24 hours a day, 5 days a week from Sunday until Friday. For specific trading timetable please check our Instruments Specifications page (available at [www.eightcap.eu](http://www.eightcap.eu)).

In order to purchase the specific CFD, the investor must have sufficient margin in his account. The required margin for CFDs commodity contracts, is 10%. The normal required margin for gold commodity contract is 5%. This means that in order to open a transaction of \$10,000 (deal size) on commodity contracts, the investor will need to have a minimum margin of \$1,000 in his account and for gold commodity contract \$500. This represents a leverage of 1:10 for commodities other than gold and 1:20 for gold commodity. Margin requirements may be decreased at the investor’s request, subject to fulfillment of certain criteria whereas margin requirements may be increased at the Company’s discretion in cases of extreme market volatility.

The profit or loss is determined according to the following formula:

**For Buy (Long) positions:** Deal size (in units of underlying asset x [Close Bid – Open Ask] = P/L (in units of the other asset)

**For Sell (Short) positions:** Deal size (in units of underlying asset) x [Open Bid – Close Ask] = P/L (in units of the other asset)

The P/L from the closed positions is then converted into the base currency of the investor’s account, if different. This is done on the basis of the relevant Bid/Ask rate of the two currencies at the time the position is closed.

The P/L is also affected by the fees charged by Eightcap EU Ltd, as detailed below. Therefore, it is important to maintain such level of margin to support the investor’s open positions.

#### Intended Retail Investor

CFDs are intended for speculative retail investors who wish to make leveraged directional transactions and take advantage of short-term price movements on the underlying asset and have the ability to sustain the risk of loss of their entire investment amount within a short period of time. Those investors have knowledge of, or are experienced with, leveraged products and have a full understanding of how the prices of CFDs are derived as well as the key concepts of margin and leverage.

The summary risk indicator rates this product at 7 out of 7, the highest risk level, indicating a very high potential for losses due to market fluctuations or our inability to pay. This rating is based on keeping the product for up to 24 hours, during which selling may not be easy or might significantly affect your return. However, the level of risk would remain at 7, irrespective of how long this product is held. Particularly, CFDs are prone to slippage and market inaccessibility issues, with no exchange trading, capital protection, or safeguard against market, credit, or liquidity risks.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance of the product at a very high level. You may not be able to end the product easily or you may have to end at a price that significantly impacts the return on your investment. CFDs may be affected by slippage or the inability to end the product at a desired price due to unavailability of such price in the market. CFDs are OTC products and cannot be sold on any exchange, MTFs or other trading venue. There is no

capital protection against market risk, credit risk or liquidity risk. Markets may fluctuate significantly in a short period of time and we may not be able to close out your position at a price that would avoid losses greater than the margin originally deposited.

**Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may significantly exceed the amount invested.**

This product does not include any protection from future market performance **so you could lose part or all of your investment**. If the Company is not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see the section ‘what happens if we are unable to pay you’). The indicator shown above does not consider this protection.

**What happens if the Company is unable to pay out?**

**What are the costs?**

The Reduction in Yield (“RIY”) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. **Costs Over Time**

#### How long should I hold it and can I take money out early?

There is no recommended holding period or minimum holding period. There are no consequences of you choosing to close your position other than ending your exposure to the underlying at that time. Early termination may occur in the event your account has insufficient funds to support the margin requirement for your position, as a consequence of certain corporate actions, or if Eightcap EU for other reasons decides to discontinue the CFD, or if Eightcap EU were to become insolvent.
